**Solicitation Ordinance**

In March, the Board adopted a Solicitation Ordinance. The Ordinance requires solicitors who are not affiliated with a non-profit organization to apply for a permit from the Township. If you have a solicitor approach you or your home, you may inquire if they have a permit from the Township and they must show you the permit if they are asked. If they are soliciting without a permit, they may be subject to a fine. The ordinance also states that solicitors must abide by signs placed on homes that state "no soliciting".

**New Sidewalks to Be Constructed**

As part of our new budget, sidewalks will be constructed along the west side of Byron Center Avenue from 76th Street to 68th Street. This \$260,000 project will be constructed this summer and will help with pedestrian safety along this busy segment of Byron Center Avenue. Since the construction of M-6, the Byron Center corridor has become a more significant entrance to our community. Traffic volume has continued to increase along the corridor and this new sidewalk will provide for greater public safety.

**Park Improvements Approved**

Last year, many of our residents participated in a survey and community discussions about our Township Parks. In addition, I have had the opportunity to talk to residents that use our parks on a regular basis and hear their concerns and suggestions for improvements. As part of our 2013-2014 Township Budget, the Township Board will be making many of those suggested improvements to two of our parks.

Cutler Park will see an improved parking lot on the southwest side of the park as well as resurfaced basketball and tennis courts. A new Splash Park, (the only one in our area) and new restroom facilities will follow. Bi-centennial Park will also see improvements to the pavillion and restroom facilities. These upgrades follow the recommendations of our residents and will improve conditions in both of these community assets. I encourage everyone visit our public parks and Community Center and participate in our fine family centered programs.

**Chalk Art Festival Another Great Success**

The West Michigan Chalk Art Festival was another great success bringing artists and spectators from Byron Center as well as other areas of the state to our downtown area. Hundreds of spectators also attended the event to view the art and watch the creation of the chalk art. The Kids Chalking Area allowed children of all ages to participate in a fun and colorful day of activities. It was great family event and I was pleased to see many families including grandparents, parents and children filling our downtown area enjoying their day together. Thank you to the Community Wellness Foundation for all your hard work.

Now that we are in the height of gardening season, I wanted to share a resource that I rely on for my own garden and yard.

**Michigan State University Extension**

**From the Desk of the Water & Sewer Administrator...  
New in Town??? - New Service Applications**

If your name is not on your water bill and the name "Occupant" appears on your bill, you will need to come into the Township Offices to fill out an application for new service. We also require that you bring your **closing documents** and **drivers license** with you to show proof of ownership. You can find the Service Application at: [www.byrontownship.org](http://www.byrontownship.org), or at the Township Offices.

**Like a Green Lawn??? - Sprinkling Meters**

If you use a large volume of water for the purpose of sprinkling your lawn and landscaping, **please consider a separate meter for irrigation.** With a second meter you would not be billed for any sewer usage when you irrigate your lawn. For example, if you sprinkled your lawn over a billing period of 3 months using a total of 80,000 gallons, the sewer use charge alone would be about \$200.00 without a second meter. **If you had a second meter there would be no sewer use charge on any irrigation water.** The actual meter and inside plumbing inspection would cost approximately \$445.00. You can either do the plumbing yourself or have the plumber plumb in the spacer bar in accordance with the Byron-Gaines Utility Authority Set Drawings. **What Are My Options??? - Utility Bill Payments**

1. You may mail in your payment to: P.O. Box 264, Byron Center, Mi. 49315
  2. You can use the 24 hour drop box located on the East side of the Township Offices - 8085 Byron Center Ave.
  3. You can pay in person at the Township Offices Mon. - Fri. 7am -5pm. with cash, check, money order, or credit card plus convenience fee. We accept MasterCard, Visa, and Discover.
  4. Credit card payments plus convenience fee, as well as E Checks can be made at: [www.byrontownship.org](http://www.byrontownship.org). Please allow 2-3 days for processing. All payments accepted after 5pm will not be posted until the next business day. We will not accept credit card payments over the phone.
  5. Another option you have is to sign up for Automatic Funds Transfer; the amount due will be taken directly out of your checking or savings account around the 20th of the month that your bill is due. Forms are available at: [www.byrontownship.org](http://www.byrontownship.org), or at the Township Offices. **There is no fee for this service.**
- **Payments must be received before 5pm. on or before the due date or they are late.**

The Byron Township Recreation Department takes pride in offering activities to people of all ages. The Recreation Department is housed in the Community Center located in Whistlestop Park. Recreation programs are held in Township parks, the Community Center and in the local school buildings. The Community Center includes a full size gymnasium, fitness center, multipurpose rooms, lounge areas with Wi-Fi, and pool tables. There is a membership fee to use the gymnasium and fitness center. We offer affordable daily, monthly or annual rates. You do not have to be a member of the Community Center to register for programs. However, members do receive a discounted rate on the programs.

Summer tax season is in full swing. You should have received your bill the 1st week of July. If you didn't, call us. Your 2013 summer taxes are due September 14, 2013, but we are taking payments without penalty until Monday, September 16, 2013 at 5:00pm. 1% interest will be added at that time and an additional 1% the 1st of each month.

We have several options for paying your bill.

**CHECK OR CASH:** In person, dropped in drop box at the East entrance of the building, or by mail. Remember we don't accept postmarks.

**ACH WITHDRAWAL:** Sign up and we will withdraw your payment on September 1 directly from your bank or credit union. Forms are on line at [www.byrontownship.org](http://www.byrontownship.org)

**ON LINE PAY:** Go to our website and go to the Treasurer's page and scroll to "Pay Bill". A fee of approximately 3% will be charged for debit or credit card payments and 25¢ for checking and savings.

If your gross income was under \$40,000.00 for 2013, you are 62 years or older, you are disabled, or if your property is classified Agricultural Real Property, you can defer your Summer taxes until the Winter tax due date without interest or penalties. A copy of the form is on the website or we can send you one.

Sometimes it is difficult to pay the full amount of taxes by the due date. We do accept partial payments. When you make a partial payment, the interest or penalty is only added to the unpaid balance.
